ABOUT CITC

The Community Investment Tax Credit (CITC) program is a tax credit that supports community-led development initiatives and strong local partnerships by leveraging private contributions.

Donations of \$1,000 or more are eligible for a CITC Tax Credit based on credit availability. For sponsorships, the fair market value (FMV) of the goods and services received in exchange must be deducted from the contribution amount to determine the actual qualified investment and resulting tax credit allocation to the donor under the CITC program. For example, a \$3,000 sponsorship, the FMV of the tickets is \$300. So the actual qualified investment is \$2,700.

Your sponsorship may be eligible for additional tax deductions as well, to the extent of the law. Please consult your tax advisor for specific tax guidance.
